### MODE OF PAYMENT OF SCHOOL FEE

- The schedule for submission of various installments of payments can be found out by contacting the School. Generally the entire fees are covered in three installments.
- To make payment of fees convenient for the parents the School has introduced the following methods: Draft, RTGS and online payment through credit card.
- In rare cases of inexplicable delay or non-payment of fees the School may levy a penalty at the rate of 2% per month. Further the ward of any defaulter may not be allowed to participate in certain school activities or to return to the School till all the fee demands are met.

- Caution money equal to one term fee is refundable without interest at the time of leaving the School and on a production of no dues certificate, with the original receipt of the caution money. The student is expected to contribute Rs. 2000/- towards Scindia Old Boy's Association of which he becomes a life member.
- The Board of Governors has the right to change the tariff of the fees at any time, even after the registration of the student.
- The fee notice issued by the School is to be treated as the official reminder.
- The institution gives the fee receipt to the parents or guardian.
- Part payment of installment will not be accepted in any case.
- The School does not send separate bills /reminders for the fees and the advance for personal expenses. The parents are expected to automatically pay the installments before the due dates.
